Re: HYWELL JONES (Armed Robbery Rpt)

With respect to the captioned subject, please be advised that on Wednesday, 14th February 2007, Mr. Hywell Jones c/o Sea Cliff situated West Bay Street contacted Police Control Room and reported that two masked men armed with guns entered his home and robbed him along with his house guests. As a result of this, officers from the Central Detective Unit were assigned to investigate.

Information received is that sometime around 12:30am on Wednesday, 14th February 2007, Mr. Jones along with his two house guests, Mr. Jeremy O'Friel and Mr. Robert Thomas had retired to bed for the night. Shortly afterwards, they were awoken by two masks gunmen in the house, who held them at bay and beat Mr. O'Friel about the body. He was taken to the Doctors Hospital, Nassau, where he was seen by a doctor who described his injuries as serious. Before leaving, the men robbed them of the following:

- 1. Mr. Jeremy O'Friel was robbed of \$820.00 cash, a Cartier watch valued at \$4,000.00 and hisTres-600 cell-phone valued at \$500.00, along with personal effects.
- Mr. Hywell Jones was robbed of \$250.00 cash and his Black-Berry cell phone #424-4811 valued at \$1000.00, along with personal effects.

An investigation was initiated into this report. To date no arrest has been made nor has anyone been charged. Investigations are being continued.
