Dear David,

Following my previous email and correspondence with the Gibraltar Financial Services Commission (henceforth the "GFSC") I would like to provide some further clarification to avoid any misunderstandings.

In my communication of 28.07.2023 I had requested the removal of the warning posted on your website regarding the company NOVASIGMA LTD. I had mentioned that the GFSC removed the relevant warning due to the inaccuracy of its content. I have been asked by the GFSC to further clarify my statement to avoid any ambiguity or misrepresentation.

In referring to the initial Warning posted by the GFSC as inaccurate I was referring to the fact that the posting made in 2021 and is no longer applicable in 2023 as the company in question, NOVASIGMA LTD, is no longer active and its website has also taken down meaning that it no longer advertises to the general public according to the information we provided to Gibraltar.

Perhaps my choice of words was not the best but I assure you that there was no intention to mislead or miscommunicate the intention of the GFSC in removing the posting. I have kept my initial communication short and succinct as I imagine your website receives a great number of similar nature daily. My intention was to inform you of the fact that the warning has been removed from GFSC website and inquire whether your posting can be removed accordingly.
