Dear Judge Rufe:

I trust this letter finds Your Honor well. I am writing to bring to your attention certain developments pertaining to the settlement agreement approved by this Court on May 6, 2022, between Mr. Everett Stern and me.

Initially, Mr. Stern commenced payments as stipulated in the settlement agreement. Regrettably, the situation took a turn when Mr. Stern, in an attempt to create legal complications, reported the initial payments as compensation for services rendered. Consequently, I found myself obligated to pay fees as a merchant due to this misrepresentation.

Upon advising Mr. Stern to adhere to truthfulness and cease such actions, the payments abruptly ceased altogether. Throughout the entirety of 2023, there were only about three payments received¹, leaving a substantial outstanding balance.

While I acknowledge that the matter appears administratively closed on Your Honor's docket, I am of the understanding that the nature of the settlement agreement allows for Your Honor's supervisory jurisdiction. I respectfully request the court's intervention to compel Mr. Stern to fulfill his settlement-agreement obligations and settle the remaining balance owed.

Furthermore, considering the prolonged duration since the settlement agreement's approval, I request a review of the amount owed, taking into account the impact of inflation over the past six years.

In light of Mr. Stern's refusal to fulfill his financial obligations, I am seeking the imposition of strict penalties, which may include measures such as wage garnishment.

I appreciate Your Honor's attention to this matter and look forward to the court's decisive action.
